## The Village of Kairos Rates Letter

Effective March 15, 2023

At The Village of Kairos, we are always thinking about the future and how we can best provide care to facilitate the healing of the wounded.

We continue to evolve our unique therapy program and implement new somatic and attachment focused therapies to enhance the Village of Kairos experience for adolescents, parents, couples, and adults.

With unique programs for clients across the lifespan, The Village of Kairos offers every client a chance to experience renewed hope and face challenges, form healthy relationships, and make lasting healing in their trauma stories.

**Eboni Webb PsyD, HSP:** Dr. Webb is a licensed psychologist and is the owner of the Village of Kairos. Dr. Webb manages, supervises, and oversees all Village staff as well as independent contractors. She has received extensive Level 1 training and certifications in Comprehensive DBT from [Dr. Lane Pederson, PsyD, LP, DBTC](#) and [Michael Maslar, PsyD](#). She has obtained her Level 3 (advanced certified practitioner) certification in [Sensorimotor Psychotherapy](#).

Dr. Webb provides extensive training and ensures providers are certified in a minimum of one therapeutic modality.

### Current Rates

**Village Initial Consultation Rate (\$100):** 60-minute session to meet with a Village clinician to discuss treatment options, identify your initial goals, and determine if DBT therapy is a good fit.

**Village Intake Rate (\$180):** 45 to 90-minute session to meet with your chosen Village clinician to conduct informed consent, review intake form, complete symptoms assessment, and develop treatment plan.

**Initial State of the Union\* (\$360):** 60-minute family session with Dr. Webb and your family's assigned clinicians to set goals, expectations, and develop a treatment plan. **Required for The Village Family Model.**

**Village Psychological Evaluation Rate (\$2000 total):** 3 to 4 sessions to receive a thorough diagnostic evaluation to determine an appropriate diagnosis for presenting cognitive, emotional, and/or behavioral concerns. **Required for all program admissions.**

<b>Sensorimotor Psychotherapy / DBT Therapy / Paired Attachment with Dr. Webb (\$400) *not accepting new clients*</b>
<b>Standard Psychotherapy / DBT Therapy with Licensed Providers (\$180)</b>
<b>Parenting Therapy with Licensed Providers (\$180)</b>
<b>Standard Psychotherapy / DBT Therapy / Parenting Therapy with an Intern (\$80)**</b>

Please note:

\*Monthly State of the Union sessions are required for The Village Family Model.

\*\*Intern rates are subject to change.

**Village Group Rates (unless otherwise stated):**

<b>Parenting DBT Skills Group with Dr. Webb</b>	\$80/week
<b>Individual DBT Skills Groups</b>	\$80/week
<b>Family Model DBT Skills Groups</b>	\$60/week for child, \$60 – \$80/week for parent(s)

**In-the-Community Rates:** Part of the Village mission is to provide integrated, wrap-around care to ensure you are fully supported in the healing process. We are committed to going the extra mile by providing services outside of the therapy office when deemed appropriate (home, office, jail/detention center, school, etc.). In order to ensure we can maintain the level of care we strive to provide, we will charge the below fees based on the clinician’s designated status and the accumulated length of time spent on providing services (travel time to and from the nearest office in addition to the length of session).

**Each additional 15 minutes is \$60 for each rate noted above.**

**Intersession Contact Rates:** Consultation and collaboration with you or your treatment team (psychiatrist, physician, family members, probation officer, lawyer/attorney, etc.) is a critical part of the treatment process in ensuring an appropriate standard of care along with providing your therapist adequate data to develop a comprehensive treatment plan. In some cases, intersession communications may need to occur on a more frequent basis (beyond an initial consultation at start of treatment). If this the case, the below rates will apply:

5 – 15 minutes	\$60
15 – 30 minutes	\$120
30 – 45 minutes	\$180
45 – 60 minutes	\$240

**Out of Network Provider Status**

As an out-of-network provider, we do not work directly with any insurance providers and do not provide in-network services. However, we are pleased to provide you with a monthly superbill (receipt of services) to obtain reimbursement for services rendered in the Village of Kairos. Currently, insurance companies are reimbursing most consistently for 45-minute individual sessions. We will supply you with diagnostic and billing codes for your insurance company to reimburse at your established out-of-network benefits. However, we cannot guarantee full coverage of our services and we will offer services beyond the 45-minute timeframe when indicated from our mutually agreed upon treatment plan.

## Process

- Step 1: Initial Consultation
- Step 2: Orientation State of the Union (The Village Family Model only)
- Step 3: Intake with Clinician
- Step 4: Psychological Evaluation

## Missed or Cancelled Appointments (Note: A session is considered canceled if you are 15 minutes late to your appointment)

- There is a 24-hour notification required to cancel any appointment.
- You are responsible for the full fee for the session if your appointment is not cancelled with the proper notification (except in cases of emergencies or illness to be determined with therapist).
  - The following charge will be applied:
    - 100% of session fee for failure to cancel session within 24 hours of scheduled appointment
- Group sessions are noncancelable and charged on a continuum unless you withdraw from the group in writing.

## Bank Charges/Merchant Services

- We accept credit/debit cards and cash.
- We bill daily for completed sessions.
- We require you to keep a credit/debit card on file to cover alternative forms of payment that are not rendered at time of service.
- If you plan to use cash for services and DO NOT provide payment at time of service, we reserve the right to charge the credit/debit card on file.
- You are responsible for any fees incurred due to bounced or returned checks.
- If the card we have on file is declined, we will not schedule future appointments until a new card is put on file or balance is reconciled.
